During the current financial period the company was active as trade agent for liquid gas and received commission.


NOTE



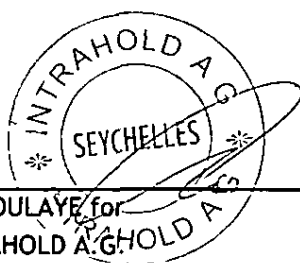
