During the current financial period the company was active as advertising and marketing consultant and received commission.

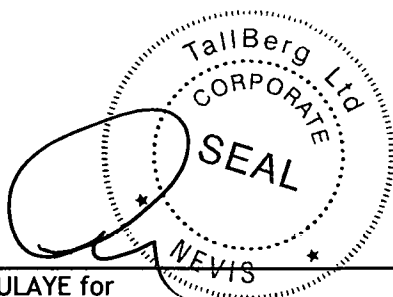
NOTE

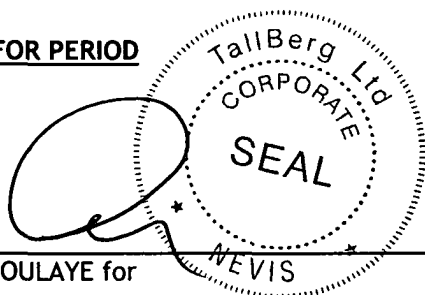

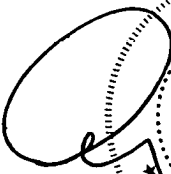

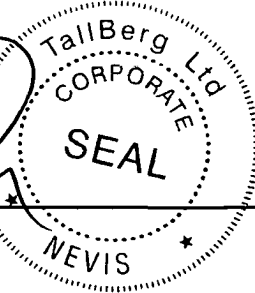
