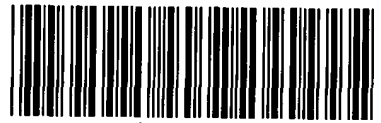



The Partners present their report together with the financial statements for the year ended 31st October 2019.


The principal activity of the partnership was that of Management Consultancy activities.
