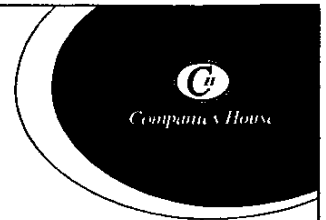

Notify all parties
