During the current financial period the company was active as consultant for investment business and received commission.

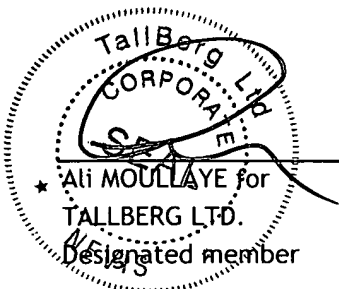
NOTE

RESPONSIBILITY

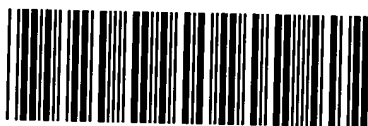

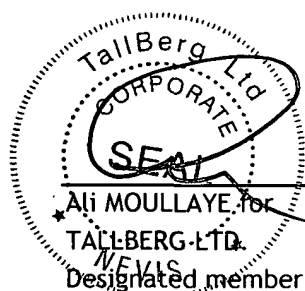

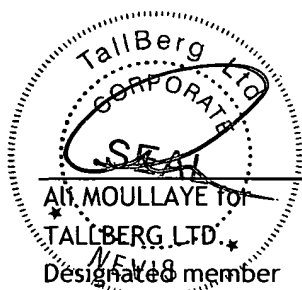
