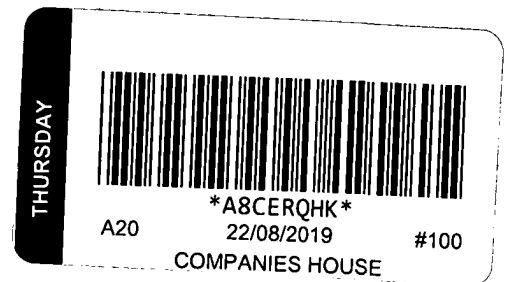
RESPONSIBILITY


