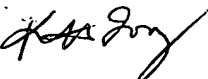
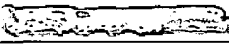

### Notify all parties

This applies from the day of application and before the day on which the application is finally dealt with or withdrawn. Please check the guidance, which contains a full list of those who must be notified. Failure to notify interested parties is an offence. It is advisable to obtain and retain some proof of delivery or posting of copies to notifiable parties.

### Withdrawal of striking off application by a LLP

If the LLP ceases to be eligible for striking off at any time after the application is made, and before the application is finally dealt with, as specified in section 1009 of the Companies Act 2006, then the application must be withdrawn using form LL DS02 'Withdrawal of striking off application by a Limited Liability Partnership (LLP)' available from our website: [www.companieshouse.gov.uk](http://www.companieshouse.gov.uk)
