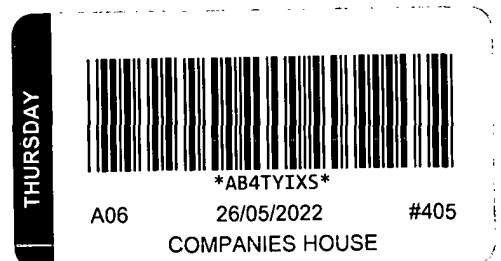

NOTES TO THE FINANCIAL STATEMENTS

YEAR ENDED 30 SEPTEMBER 2021

1. General information and basis of preparation

East Midlands Chambers of Commerce International LLP is a Limited Liability Partnership incorporated in England and Wales, within the United Kingdom. The address of the registered office is Commerce House, Millennium Way, Dunston Road, Chesterfield, S41 8ND.

The financial statements have been prepared under the historical cost convention in accordance with FRS 102 Section 1A – The Financial Reporting Standard applicable in the UK and Republic of Ireland and the Companies Act 2006 and in accordance with the Statement of Recommended Practice 'Accounting for Limited Liability Partnerships' issued in December 2018.

The Financial Statements are prepared in sterling which is the functional currency of the LLP.

2. Dormant status

The limited liability partnership was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 30 September 2021. The limited partnership has not traded during the year or during the preceding financial period. During these periods, the limited liability partnership received no income and incurred no expenditure and therefore made neither profit nor loss.
