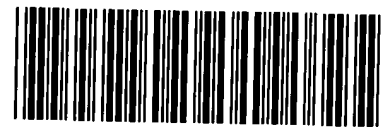



1. General Information
