PRINCIPAL ACTIVITY & REVIEW OF BUSINESS


During the current financial period the company was active as trade agent for oil products and received commission.


NOTE

RESPONSIBILITY

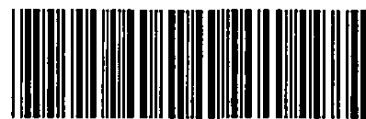
