During the current financial period the company was active as trade agent for construction materials and received commission.

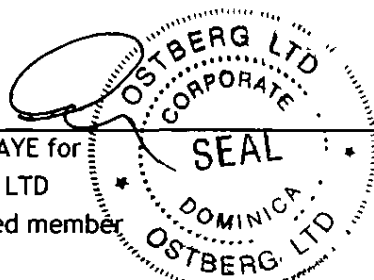
**NOTE**

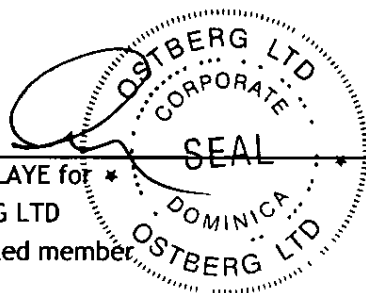


