During the current financial period the company was active as trade agent for building materials and received commission.

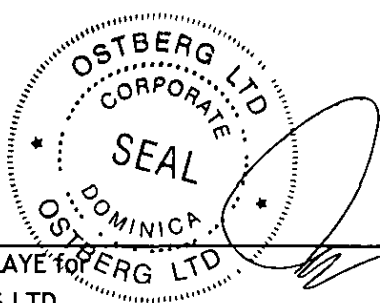
NOTE

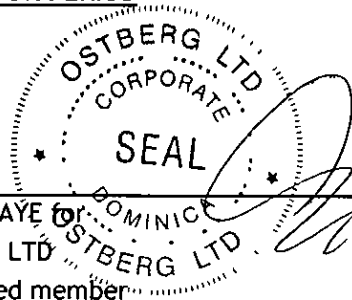


