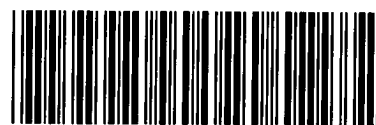
The members of the partnership are responsible for maintaining adequate accounting records and for the safeguarding of the books and assets of the Company.


