#### PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

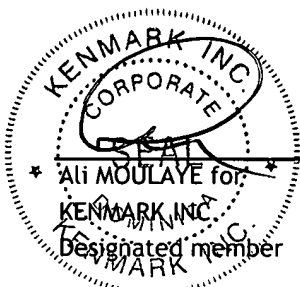
During the current financial period the company was active as consultant for IT services and received commission.

#### NOTE

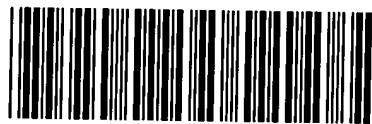

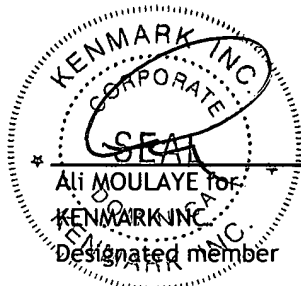

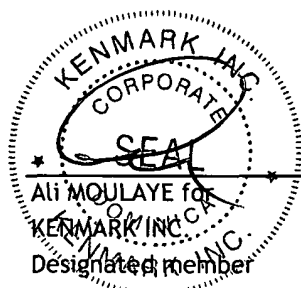
