During the current financial period the company was active as consultant for IT services and received commission.


NOTE

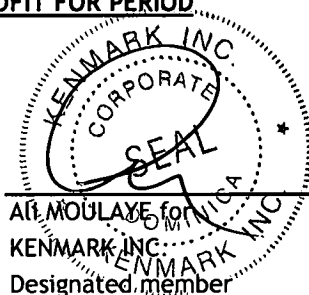


