During the current financial period, the company was dormant.

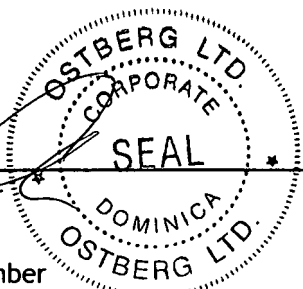
NOTE

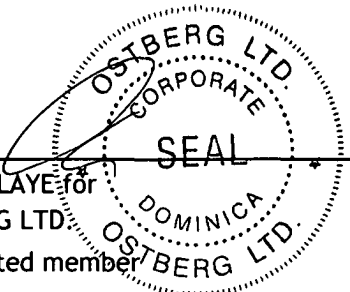
