**DRAFT ORDER**

**UPON** the Applicant's Application dated 26 November 2021 (the "**Application**")

**AND UPON READING** the evidence

**AND UPON** Paul Anthony Higley confirming that he has no objection to the Application

**AND UPON** Engin Faik confirming that he has no objection to the Application insofar as it relates to Jademark Limited

**AND UPON** the Secretary of State having been provided with notice of the Application and supporting documentation

**IT IS ORDERED THAT:**

1. Each of the County Court Hearing Centre or District Registry cases listed in Schedule A (attached to this order) (the “**County Court Cases**”) be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List (ChD) solely for the purpose of and insofar as is necessary for considering the Application and the making of this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.
2. Paul Anthony Higley (the “**Outgoing Officeholder**”) be removed from office in respect of each of the cases listed in Schedules 1 to 5 (attached to this order) (the “**Block Transfer Cases**”) from the date of this order.
3. Matthew Robert Howard and Stuart David Morton (the “**Replacement Officeholders**”) be appointed respectively as the joint replacement officeholders in respect of each of the Block Transfer Cases as set out in paragraphs 4 to 8 below.
4. The Outgoing Officeholder be removed from office as joint or sole liquidator of the companies in creditors’ voluntary liquidation listed in Schedule 1 attached hereto with effect from the date of this order pursuant to section 108 of the Insolvency Act 1986 (the “**Act**”) and Matthew Robert Howard and/or Stuart David Morton be appointed as joint liquidator in respect of the said companies as specified in Schedule 1 with effect from the date of this order pursuant to section 108 of the Act.
5. The Outgoing Officeholder be removed from office as joint liquidator of the companies in members’ voluntary liquidation listed in Schedule 2 attached hereto with effect from the date of this order pursuant to section 108 of the Act and Matthew Robert Howard or Stuart David Morton be appointed as joint liquidator in respect of the said companies as specified in Schedule 2 with effect from the date of this order pursuant to section 108 of the Act.
6. The Outgoing Officeholder be removed from office as joint or sole liquidator of the companies in compulsory liquidation listed in Schedule 3 attached hereto with effect from the date of this order pursuant to section 172(2) of the Act and rule 12.36(2) of the Insolvency (England and Wales) Rules 2016 (the “**Rules**”) and Matthew Robert Howard

and/or Stuart David Morton be appointed as joint liquidator in respect of the said companies as specified in Schedule 3 with effect from the date of this order pursuant to sections 168(3) and (5) of the Act and rule 12.36(2) of the Rules.

7. The Outgoing Officeholder be removed from office as joint administrator of the companies in administration listed in Schedule 4 attached hereto with effect from the date of this order pursuant to paragraph 88 of Schedule B1 of the Act and rule 12.36(2) of the Rules and Matthew Robert Howard or Stuart Morton be appointed as joint administrator in respect of the said companies as specified in Schedule 4 with effect from the date of this order pursuant to paragraphs 63, 91 and 95 of Schedule B1 of the Act and rule 12.36(2) of the Rules.
8. The Outgoing Officeholder be removed from office as joint or sole trustee in bankruptcy of the bankruptcy estates listed in Schedule 5 attached hereto with effect from the date of this order pursuant to section 298 of the Act and rule 12.36(2) of the Rules and Matthew Robert Howard and/or Stuart David Morton be appointed as joint Trustee in Bankruptcy in respect of the said bankruptcy estates as specified in Schedule 5 with effect from the date of this order pursuant to sections 298 and 303(2) of the Act and rule 12.36(2) of the Rules.
9. Subject to paragraph 13 below no additional reports or receipts and payments accounts shall be obliged to be filed consequent upon the removal of the Outgoing Officeholder and his being replaced pursuant to this order.
10. In the cases listed in Schedules 1 to 5 (inclusive) the Outgoing Officeholder be released and discharged from all liability both in respect of acts or omissions of his as administrator, such release and discharge to take effect 56 days from the date of the advertisement, save in respect of any objection made pursuant to paragraph 15 of this Order, or claim notified to the Replacement Officeholders pursuant to the Act and/or pursuant to such other provisions as may apply on or prior to the notice date; or otherwise on application to the Secretary of State.
11. Where the appointments referred to in this Order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.

12. The Replacement Officeholder(s) shall file a copy of this Order with each of the County Courts Hearing Centres and District Registries listed in Schedule A.
13. Without incurring any additional expense for any of the said estates, the Applicants or Replacement Officeholders shall notify each creditor of the respective estates of this Application and the Order by way of notice at the same time as the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:
  - (i) An explanation of the effect of the Order;
  - (ii) Express reference to the permission to apply contained in paragraph 15 below;
  - (iii) Where creditors' committees or liquidation committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rules 3.63, 6.25, 7.61 or 10.77 (as the case may be) of the Rules has not already been provided as part of the report, it is open to that committee to require the Applicants, Outgoing Officeholder or Replacement Officeholders to provide an account of the administration of the estate, including a summary of receipts and payments;
  - (iv) Where creditors' committees or liquidation committees have not been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the Applicants, Outgoing Officeholder or Replacement Officeholders do provide an account of the administration of the estate, including a summary of receipts and payments.
  - (v) Notification that if any of the Applicants, Outgoing Officeholder or Replacement Officeholders have been required to provide the information referred to in subparagraphs 13(iii) and/or 13(iv) above, whether by a liquidation committee or creditors' committee or by court order on the application of any creditor(s), the costs of any appointed officeholder of so complying will, unless there are good reasons to the contrary, be paid as an expense of the estate; and
  - (vi) In each of the cases listed in Schedules 1, 2, 3, 4 and 5, notification to each creditor of their right under regulations 11(2) or 25 of the Insolvency Regulations 1994 to require the Replacement Officeholders to supply a statement of receipts and payments free of charge.

14. The creditors in each of the cases listed in Schedules 1, 3, 4 and 5 and the members in each of the cases listed in Schedule 2 shall be notified of this order by way of one composite notice (the “**Advertisement**”) to be published in the Gazette within 14 days of receipt of the sealed order.
15. Each creditor or (as relevant) member of each estate who has an objection to this Order has permission to apply to vary or discharge this Order. Creditors or (as relevant) members shall have 56 days from the date of the Advertisement to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the cases listed in Schedules 1, 2, 3, 4 and 5 until further or other order by the Court.
16. The Replacement Officeholders shall file any appropriate notices in respect of the removal of the Outgoing Officeholder and the appointment of the Replacement Officeholders appointed pursuant to paragraphs 3 to 8 of this Order with the Registrar of Companies and the Secretary of State for Business Energy Innovation and Skills (Insolvency Service) as appropriate and as soon as reasonably practicable.
17. Permission is given to the Secretary of State to apply to vary this Order at any time up to 56 days after the notices referred to in paragraph 14 above are published.
18. In the event that, as a result of the implementation of this Order, Price Bailey LLP incurs any additional cost in respect of the administration of those estates where the Outgoing Officeholder was the officeholder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by Price Bailey LLP and shall not be charged as an expense of the administration of those estates.
19. The costs of this Application (including VAT) shall be met by Price Bailey LLP.
20. The Replacement Officeholders have the right to apply to the Court to amend this Order to include (if appropriate) any appointments held by the Outgoing Officeholder which have been inadvertently omitted from the Application.
