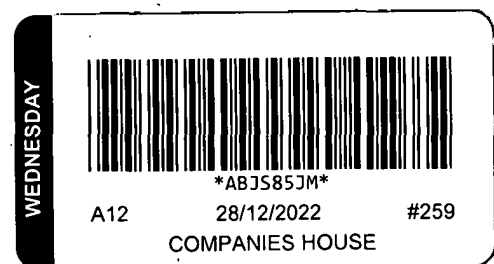



1.1 Basis of Preparation of Financial Statements
