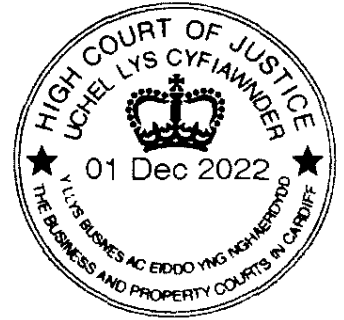

UPON THE APPLICATION by a Claim Form dated the 15 October 2022 of Richard McGlynn the Claimant and a designated member of the above named Acreleaf LLP (hereinafter called "the LLP")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of His Majesty to the relief sought by this Claim as appears from the evidence of service of Richard McGlynn and the exhibit thereto

AND the Claimant undertaking that:

- (A) the LLP will not carry on business or operate in any way other than to take the necessary steps to realise and distribute the funds in the bank account referred to in paragraph 6 of the Witness Statement of Richard McGlynn dated the 10 October 2022 (the action) according to law



- (B) he will notify the Registrar of Companies immediately on the conclusion of the action
- (C) the designated members of the LLP will immediately on the expiry of 3 months from the conclusion of the action apply to the Registrar of Companies for the voluntary strike off of the LLP under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Acreleaf LLP be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the LLP is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the LLP to OC439535 LLP
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the LLP is thereupon to be deemed to have continued in existence as if its name had not been struck off


(4) the Registrar of Companies do advertise notice of this Order in her official
