

I write further to my appointment as Administrator of the above company on 18 January 2005, to provide creditors with a progress report since my last report dated 6 July 2005 and to provide notice under rule 2.111(1) of the Insolvency Act 1986, this notice being to advise the creditors of an automatic end of the administration order.

Creditors will recall that on 16 November 2005 that a proposal for a company voluntary arrangement was approved by creditors. The purpose of the voluntary arrangement is to distribute a dividend to the unsecured creditors of the company which is estimated to be approximately 5.3p in the £. I attach a copy of my up to date receipts and payments account covering the twelve month period from 18 January 2005 to 17 January 2006. Creditors will note from the receipts and payments account that a sum of £170,298.68 has been transferred to myself as Supervisor of the Voluntary Arrangement

As at 10 January 2006 my total time costs were in the order of £18,477.25 representing 139 hours at an average hourly chargeout rate of £132.93. Attached to this report is a summary of the work done in accordance with SIP9. Also attached to this report is a summary of my firm's current chargeout rates which are reviewed annually on 30 April and a copy of the creditors guide to administrator's fees for information purposes.

I have drawn fees of £16,000 plus VAT in respect of these time costs and these were agreed by the debenture holder. The balance of my time costs have been written off.

If creditors require any further information whatsoever, please do not hesitate to contact this office. I confirm that a copy of this report has been filed with the appropriate authorities.
