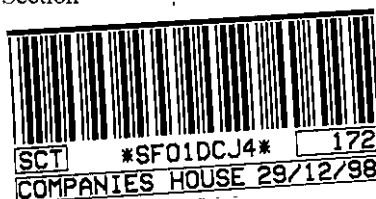



"Secured Indebtedness" means the aggregate of (a) the Loan (as defined in the Loan Agreement) and interest thereon (and interest on any unpaid interest thereon and on any other sums of money on which interest is stated in the Loan Agreement to be payable) and (b) all such expenses, claims, liabilities, losses, costs, duties, fees, charges or other moneys as are stated in the Deed of Covenant to be payable by the Company to or recoverable from the Company by the Bank or any Receiver (or in respect of which the Company agrees in the Deed of Covenant to indemnify the Bank or any Receiver) whether actually or contingently, presently or in the future together with interest thereon as provided in the Loan Agreement and the Deed of Covenant and (c) all other sums of money from time to time owing to the Bank under the Security Documents (as hereinafter defined) or any of them whether actually or contingently, presently or in the future;

"Security Documents" means any such documents as is defined in the Loan Agreement as a Security Document (including the Mortgage and the Deed of Covenant and, where the context so admits, the Loan Agreement itself) or as may from time to time be executed by any person as security for or as a guarantee of the Secured Indebtedness or any part thereof as the same may hereafter be supplemented and/or amended and references to the "Security Documents" shall mean all or any of them, as the context so requires;
