

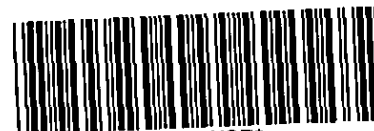
- (a) The Company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.
