The Lord Ordinary having heard Counsel for the Noters, no answers having been lodged, allows the prayer of the Note to be amended at the Bar; dispenses with the need for reservice; Discharges the Administration Order made on 12 October, 2001, in respect of Atlantic Telecom Group PLC under the Insolvency Act, 1996; direct the Noters to make over the assets of the said company which are under their control as administrators to Mr. Pearson and Mr. Bennet in their capacities as joint liquidators of the said company, subject always to the rights of the Noters to retain assets of the company viz; their rights under section 19 (4) of the 1986 Act, in respect of their remuneration and expenses as joint administrators; their rights under section 19 (5) of the 1986 Act in respect of any debts or liabilities incurred by them under any contracts entered into on the company's behalf in the carrying out of their functions as administrators; and their rights in terms of the interlocutor dated 5 October 2001 in respect of any debts or liabilities incurred by the Noters under the appointment; Remits to Archibald Gray W.S. CA. Of Kroll Buchler Philips, Glasgow, to determine the Noters remuneration as joint administrators and under the interim appointments; Remits to the Auditor of Court to report and appoints the Auditor of Court and said Archibald Gray to confer prior to submission of their respective reports.
