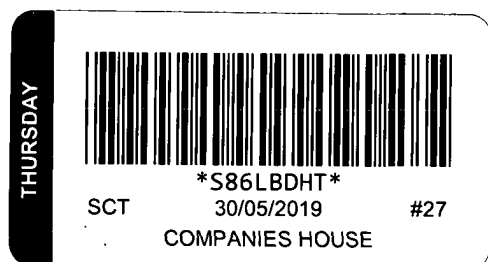

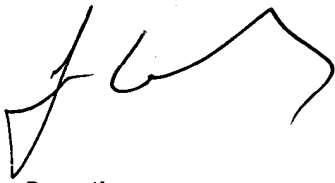

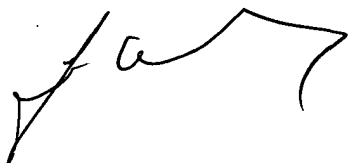

1. Accounting policies

1.1 Basis of preparation of financial statements

Gleneagles of Scotland (Woollens) Limited (the "Company") is a company incorporated and domiciled in the UK.

These financial statements are drawn up for the 78-week period ended 25 August 2018. The comparative figures are for the 52-week period ended 25 February 2017.

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 101 'Reduced Disclosure Framework' and the Companies Act 2006.

The company's financial statements are presented in Sterling.
