1. Accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. 2. Company member guarantee

The Company is limited by a guarantee which is given by the member of the Company, Bank of Scotland plc, appointed on 7 March 2017. The extent of this guarantee is to such amounts as may be required but not exceeding £5.

3. Related party transactions

The Company is limited by guarantee and does not have an ultimate parent company The Company is controlled by Lloyds Banking Group (incorporated in Scotland) which is also the parent undertaking of the largest group of undertakings for which group financial statements are drawn up. Bank of Scotland plc is the parent undertaking of the smallest such group of undertakings. The Company's related parties include other companies in the Lloyds Banking Group and the Company's key management personnel. Key management personnel are those persons having authority and responsibility for planning, directing and controlling the activities of the Company, which is determined to be the Company's directors.

Key management personnel are employed by other companies in the Lloyds Banking Group and consider that their services to the Company are incidental to their other activities within the Group.
