1. DEFINITIONS:

In this Paper Apart the following terms shall have the meaning ascribed to them as follows:

"the Bank Floating Charge"

means a Floating Charge in favour of the Bank dated Twenty-seventh September Nineteen hundred and ninety and registered with the Registrar of Companies on Fourth October Nineteen hundred and ninety.

"the Bank Security"

means Standard Security by the Company in favour of the Bank dated Fourth August Nineteen hundred and ninety-nine and about to be registered in the Land Register of Scotland.

"Bass"

means Bass Brewers Limited, incorporated under the Companies Acts and having their Registered Office at One hundred and thirty seven High Street, Burton-upon-Trent (hereinafter referred to as "the Company") and trading in Scotland as Tennent Caledonian Breweries.

"the Bass Security"

means a Standard Security granted by the Company in favour of Bass dated the Fifteenth day of February Two Thousand and about to be registered in the Land Register of Scotland.

"the Bass Security Limitation"

means the sum of SIX HUNDRED THOUSAND POUNDS Sterling (£600,000).

"The Securities"

means the Bank Floating Charge, the Bank Security and the Bass Security.

The singular shall include the plural and vice versa.

2. RANKING

The Instrument of Alteration provides that the Securities shall rank in the following order of priority:

FIRST: The Bass Security for sums due by the Company to Bass up to the Bass Security

Limitation.

SECOND: The Bank Security for all sums due and to become due by the Company to the

Bank.

THIRD: The Bass Security for all sums due and to become due by the Company to Bass.

FOURTH: The Bank Floating Charge on the reversion until all sums due by the Company to

the Bank are satisfied.

All of the foregoing rankings shall subsist notwithstanding the date or dates on which the respective Securities are registered or recorded (as the case may be) or the terms of the Securities or the terms of any Instrument of Alteration dated prior to the Instrument of Alteration affecting any of the Securities.

3.

The provisions as to ranking set out in the Instrument of Alteration shall be valid and effective, and the Securities shall be given effect subject to the provisions as to ranking set out in the Instrument of Alteration irrespective of the date or dates on which sums due or becoming due to the Bank and/or Bass respectively have or shall become due, and irrespective of fluctuations in such sums.
