MEMORANDUM of ASSOCIATION

of

#### SEAFORTH MARITIME (HIGHLANDER) LIMITED

- 1. The name of the Company is "SEAFORTH MARITIME (HIGHLANDER) LIMITED"
- 2. The registered Office of the Company will be situate in Scotland.
- 3. The objects for which the Company is established are:-
  - (1)To carry on in the United Kingdom or elsewhere the trade or business of ship owners, charterers of ships or shipping property and ship brokers and to build or otherwise acquire ships, boats and other craft by purchase, agreement or charter for such money or other consideration as may be determined with all equipments and furniture thereto belonging and shares or interests in ships or in Companies owning ships and to sell and dispose of vessels or other property so acquired or any of them with the tackle, stores and appurtenances thereof.
  - (2)To work, let out for hire or otherwise employ the ships from time to time belonging to chaltered or managed by the Company and in particular to enter into charterparties by way of demise or bare boat charterparties, time charterparties or voyage charterparties and to turn to account the assets of the Company by selling, hiring or leasing the same or otherwise as may seem in the interests of the Company.
  - (3) To pay out of the funds of the Company all costs and expenses of or incidental to the formation or registration of the Company in the issue of its capital and debentures including brokerage and commission.
    - (4)To alter the Memorandum and Articles of Association of the Company in manner allowed by law.

It is declared that the foregoing sub-clauses shall be construed independently of each other and none of the objects herein contained shall be deemed to be merely subsidiary to the objects contained in any other sub-clause.

- 4. The liability of the members is limited.
- 5. The Snare Capital of the Company is £100 divided into 100 Shares of £1 each with power to increase or divide the Shares in the Capital for the time being into different classes, maving such rights, privileges and identages as to voting and otherwise as the Articles of Association may from time to time prescribe.

We the several persons whose names, addresses and descriptions are subscribed, are desirous of being formed into a Company in pursuance of this Memorandum of Association and we respectively agree to take the number of 3 ares in the Capital of the Company set opposite our respective names.


