1. Accounting policies

1.1 Basis of preparation of financial statements

James Pringle Textiles Limited (the "Company") is a private company incorporated, domiciled and registered in the UK. The registered number is SC79554 and the registered address is Waverley Mill, Langholm, Dumfriesshire, DG13 0EB.

These financial statements are drawn up for the 52-week period ended 29 February 2020. The comparative figures are for the 27-week period ended 2 March 2019.

The financial statements have been prepared under the historical cost convention and in accordance with Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006.

During the dormant period, the company transitioned from preparing the financial statements in accordance with Financial Reporting Standard 101 to Financial Reporting Standard 102. There were no identified differences arising from this transition.

The company's financial statements are presented in Sterling.
