#### 1. Accounting policies

##### 1.1 Basis of preparation of financial statements

James Pringle Textiles Limited (the "Company") is a private company incorporated, domiciled and registered in the UK. The registered number is SC079554 and the registered address is Waverley Mill, Langholm, Dumfriesshire, DG13 0EB.
