Report of the Trustees for the year ended 31 March 2019

The Trustees present their annual report and financial statements of the charity for the year ended 31 March 2019.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's trust deed, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended), the Companies Act 2006 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland.

The legal and administrative information on page one forms part of this report.

Principle activities and charitable purposes

Spinal Injuries Scotland is the national voluntary organisation concerned with new and long-term spinal cord injured people, their relatives and friends, along with those involved in the management, care and rehabilitation of the injury.

Our charitable aim is "the advancement of health".

Strategic Approach

Spinal injuries Scotland (SIS) advances its charitable aims by channeling its efforts via the following three strands:

- Support those coming to terms with a SCI
- Inform those living with SCI
- Influence decision makers and designers as they shape the word for those with SCI

We deliver a nationwide, membership focused service, which is delivered through programs and projects designed to meet the needs of our members. Having a spinal cord injury (SCI) is a traumatic and life changing event. The process of rehabilitation is both a physical and emotional challenge.

The stages a person with SCI will experience are:

- initial triage undertaken by the emergency services
- stabilizing the injury
- treatment and rehabilitation at the Queen Elizabeth National Spinal Injuries Unit, Glasgow (QENSIU)
- discharge home
- continuing rehabilitation and reintegration into the local community and workplace

We generally begin to get involved with a patient during their treatment and rehabilitation within the Queen Elizabeth National Spinal Injuries Unit, Glasgow. The QENSIU is where people come from all over Scotland as inpatients to receive their treatment. In some cases, this may result in the patient being in the Unit for 6 months or more which can result in having less daily contact with their family and friends. Being apart from family and other support networks at such a vulnerable time can have a significant impact on a person's health and recovery with SCI. Feeling isolated and lonely can also have a negative impact on a patient's mental health when they are already trying to come to terms with a major trauma.

Rehabilitation is a long and demanding process for the person who has sustained the injury as well as for their family and friends.

Our Principle Activities

Spinal Injuries Unit

Peer Support Volunteers

Our team is made up of the Peer Support Coordinator who supervises and supports the Peer Support volunteers in the Spinal Unit. Everyone in the team has a spinal injury themselves which helps them relate to how the patients are feeling about the situation they find themselves in. The Peer Support Team is accessible in the Glasgow Unit 5 days per week. This service begins with an informal chat with patients and in some cases, their families and friends.

The patients often need support to come to terms with their situation and having someone to talk to who has experiences of the same journey can help. The volunteers can offer impartial advice and an opportunity to talk frankly about matters that patients may not feel able to discuss with family, friends and clinicians.

Social Events within QENSIU

These events are developed in consultation with the Lead Clinician of the QENSIU and the Clinical Lead Nurse. The sessions are intended to offer a relaxed and lighthearted evening of activities and events. Previous sessions have included quiz nights, a Burns supper and a take away pizza night. The events are well attended by families and patients.

Patient Education Sessions

Developed by the Lead Clinical Nurse and Medical Director of the QENSIU, these sessions offer patients the opportunity to learn about a range of issues that may impact on their day to day life. Our Peer Support team also attend the sessions to offer support from the perspective of someone who has lived with similar challenges.

Spinal Manual

The charity continues to fund the production of the Spinal Manual ('Living with a Spinal Cord Injury) in conjunction with the specialist medical team at the QENSIU. This manual is given to every patient who attends the QENSIU. Our volunteers knowledge and experience is drawn on to create this reference guide for patients. The Guide also includes a section where patients can record their important medical information.

Our Principle Activities (continued)

Spinal Injuries Unit - Review Clinic and Outreach

Outpatients and Outreach Clinics are undertaken by a multidisciplinary team of specialist clinicians. Clinics take place in Glasgow, Aberdeen, Huntly, Inverness, Arbroath, Dumfries and the Scottish Borders.

Our Peer Support team attend the clinics to listen to our members concerns and issues and, where appropriate, share their experience of facing similar challenges. Some of our members have been attending the clinics for many years. Despite their injury occurring many years ago patients may continue to need support and encouragement from the charity and their medical team.

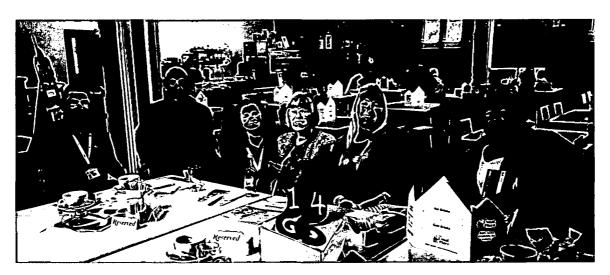
During 2018/2019, we recruited three additional part time members of staff, to enhance our Peer Support Team. This was in response to feedback from patients and members who felt that there was not enough support in their local areas, and that they would benefit from meeting up with people who knew what they were going through.

These new Peer Support Advisors cover Aberdeen, Inverness, Dumfries & Galloway and the Scottish Borders. The Advisors arrange events and coffee meetings which enable people living with SCI to meet others in a similar situation. This allows our team to have face to face or group discussions about issues such as mental health, relationship issues, physical health matters, employment and financial issues as well as the ongoing challenge of maintaining friendships and interacting with the local community.

In 2019/20 we hope to increase the size of the team and begin providing support in other areas.

Membership Services

Castle Semple Sports Day and Annual Barbeque

This event takes place at Castle Semple, Lochwinnoch at the Royal Yachting Association Training Centre. The event offers patients in the QENSIU, our members and their families an opportunity to access sports activities using adapted or bespoke equipment suitable for people with a SCI.



Clober Farm - accessible accommodation

This converted property in Milngavie is an ideal location for a person with a SCI seeking a base from where to have a city break or tour of the local countryside. In easy reach of places such as Loch Lomond, Glencoe and the Trossachs, Clober Farm is a well-equipped and peaceful setting to have a break from the daily routine. Reduced rates are available for people with a spinal cord injury / SIS membership.

Safe Drive Stay Alive & Young Drivers events

These educational programmes are aimed at 6th year secondary school pupils with the aim of influencing behaviour and attitude on the road. We work in partnership with the City of Edinburgh Council, Police Scotland, NHS Lothian, Transport Scotland, Scottish Safety Camera Unit (EAST), Scottish Ambulance Service, Scottish Fire and Rescue, NHS Scotland and other voluntary organisations.

At the Young Drivers Event, a member of our Peer Support Team shares their experience of being in a road traffic collision. The feedback we receive from these events is that the talks have a profound effect on participants.

Glasgow Caledonian University



Volunteer with nursing students at Caledonia University

Each year, our Peer Support Team are invited by Glasgow Caledonian University to speak to student nurses about living with a Spinal Cord Injury from a patient's perspective. We continue to receive very positive feedback from attendees and the event usually results in many new members being recruited.

"Feedback from applicants was unanimously positive with many identifying these sessions as one of the highlights of the day. The aim was to highlight to applicants the types of values, skills and approaches that are required of nurses and that can positively and significantly impact on an individual's experience. Comments reflected how the sessions had played a significant part in confirming the applicants' desire to become nurses and make a difference when supporting individuals with healthcare needs."

Spinal Injuries Scotland Legal and Welfare Advice Line

Our partners, Digby Brown Solicitors provide this free service for our members. Initial advice can be given by phone and visits are arranged at the QENSIU or at home. Initial legal advice is free and welfare rights advice is free throughout the process, including completion of welfare benefit applications and representation at Tribunal hearings. Feedback from members is that this service has been instrumental in enabling them to access the funds and essential rehabilitation they require.

Spinal Injuries Home Delivery Service

Our partnership with Bullen Healthcare began in 2016. It offers our members a free home delivery service for prescription items and medication. Each person is allocated a dedicated personal advisor who knows their specific needs and will liaise with lead physicians and GPs. The service takes away the need for our members to monitor their stocks of prescription items or contact different stockists to find specific items. Bullen Healthcare's Services are free to Spinal Injury Scotland members and offer complimentary products.

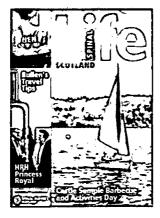

Financial Review

The accounts shown an operating deficit for the year of £22,672 (2018: £73,660) prior to unrealised gains and losses on investments.

Reserves Policy

The Board of Directors has a policy of retaining reserves to meet six months' operating costs which would be £131,715. At 31 March 2019 unrestricted funds amounted to £248,576. Excluding amounts tied up in designated funds leaves a deficit of £23,790 which falls short of this target level.

Company, Governance and Management

The Company is a recognised Scottish Charity and is limited by guarantee. It is governed by its Memorandum and Articles of Association. The Company is run by the Board of Directors, appointed at the Annual General Meeting and suitably qualified members.

The Charity has a governance framework in place with clear objectives for the charity for the next four years.

Recruitment and Appointment of Directors

The directors are appointed following the procedure as detailed in the Articles of Association. Their appointment is subject to the approval of the Board of Directors. The Board reviews the skill set of the Board and seeks to recruit suitable new directors to meet ongoing needs.

Induction and Training of New Directors

Most directors are already familiar with the practical work of the charity. New directors are provided with copies of the Memorandum and Articles of Association and receive a formal induction to familiarize them with the work of the charity and its aims and objectives.

Trustees' responsibilities in relation to the financial statements

The charity trustees (who are also the directors of the Spinal Injuries Scotland for the purposes of company law) are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing the financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2019

1. Accounting Policies

(a) Basis of preparation and assessment of going concern

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The charity constitutes a public benefit entity as defined by FRS 102.

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern.

(b) Funds structure

Unrestricted income funds comprise those funds which the trustees are free to use for any purpose in furtherance of the charitable objects. Unrestricted funds include designated funds where the trustees, at their discretion, have created funds for specific purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by the donor or trust deed, or through the terms of an appeal.

Further details of each fund are disclosed in note 17.

(c) Income recognition

Income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Donations, are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to conditions that require a level of performance before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that those conditions will be fulfilled in the reporting period.

Legacy gifts are recognised on a case by case basis following the granting of probate when the administrator/executor for the estate has communicated in writing both the amount and settlement date. In the event that the gift is in the form of an asset other than cash or a financial asset traded on a recognised stock exchange, recognition is subject to the value of the gift being reliably measurable with a degree of reasonable accuracy and the title to the asset having been transferred to the charity.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2019

1. Accounting Policies (continued)

(c) Income recognition (continued)

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank.

Income from government and other grants, whether 'capital' or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Income received in advance of the provision of a specified service is deferred until the criteria for income recognition are met.

(d) Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

All expenditure is accounted for on an accruals basis. All expenses including support costs and governance costs are allocated or apportioned to the applicable expenditure headings. For more information on this attribution refer to note (f) below.

- Costs of raising funds comprise the costs of business development costs such as salaries, materials, general expenses etc.
- Expenditure on charitable activities includes the costs undertaken to further the purposes of the charity and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure is incurred.

(e) Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised. Refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2019

(f) Allocation of support and governance costs

Support costs have been allocated between governance costs and other support costs. Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to independent examination and legal fees together with an apportionment of overhead and support costs.

Governance costs and support costs relating to charitable activities have been apportioned based on the staff time spent on each charitable activity. The allocation of support and governance costs is analysed in note 10.

(g) Tangible fixed assets and depreciation

All assets costing more than £1,000 are capitalised and valued at historical cost. Depreciation is charged as follows:

Freehold land and buildings Fixtures, Fittings and equipment Basis 0% 10-20% reducing balance

No depreciation is charged on freehold land and buildings due to the trustee's recently refurbishing the property and being committed to ensure ongoing that property is maintained on an ongoing basis such that there is no diminution of the cost.

(h) Fixed asset investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing quoted market price. The statement of financial activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The charity does not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

(i) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

(i) Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

(k) Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2019

(I) Financial instruments

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

(m) Employee Benefits

The costs of short-term employee benefits are recognised as a liability and an expense, unless those costs are required to be recognised as part of the cost of stock or fixed assets.

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the charity is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

(n) Pensions

Employees of the charity are entitled to join a defined contribution 'money purchase' scheme. The charity contribution is restricted to the contributions disclosed in note 11. There were no outstanding contributions at the year end. The costs of the defined contribution scheme are included within support and governance costs and charged to the unrestricted funds.

The money purchase plan is provided by Royal London and the plans invests the contributions made by the employee and employer in an investment fund to build up over the term of the plan. The pension fund is then converted into a pension upon the employee's normal retirement age which is defined as when they are eligible for a state pension. The charity has no liability beyond making its contributions and paying across the deductions for the employee's contributions.

(o) Taxation

The charity is a charitable company within the meaning of Paragraph 1 Schedule 6 of the Finance Act 2010. Accordingly, the company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 of Part 11 of the Corporation Tax Act 2010 and section 256 of the Taxation of Chargeable Gains Act 1992 to the extent that such income or gains are applied for charitable purposes only.

2. Legal status of the Charity

Spinal Injuries Scotland is a registered Scottish charity and a company limited by guarantee with no share capital. The liability of each member in the event of winding up is limited to £1.

3. Related party transactions and trustees' expenses and remuneration

During the year no trustees received remuneration (2018: Maureen Morrisons received £22,217) from the charity.

During the year 1 Trustees (2018: 2) received expenses of £92 (2018: £330). There were no waived expenses (2018: Nil).

During the year 1 trustee (2018: 0) made a donation of £50 (2018: £nil) to the charity.

Holywood Trust is towards the establishment of Peer support outreach clinics in Dumfries and Galloway.

The IT Fund represents money from Digby Brown which was to be used for the purchase of a new server and other monies for the purchase of IT Equipment.

Killgallioch Community Fund is to employ a Peer Support Advisor for 10 hours per week for 1 year to work within Dumfries and Galloway.

Pebbles Grant is to be used for an improvement project to their adapted holiday apartment Clober Farm in Milngavie, which includes the provision of a smart TV, Sofa, high-backed chair, floor lamp and nest of tables for the living room.
