Notes

1. Dormant Status

The company was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the year ended 31 March 2019. The company has not traded during the year or during the preceding financial year. During these periods, the company received no income and incurred no expenditure and therefore made neither profit nor loss.

The company has net liabilities at 31 March 2019. The Edrington Group Limited, the company's immediate parent undertaking, has confirmed that it will continue to support the company to enable it to meet its obligation as they fall due for a period of 12 months from the date of approval of the accounts. Accordingly, the accounts have been prepared on a going concern basis.

2. Ultimate Controlling Party

The Company is a wholly owned subsidiary of Edrington Distillers Limited whose ultimate controlling party is The Robertson Trust which is a registered charity. Copies of the financial statements of The Edrington Group Limited, which is the largest and smallest group into which these financial statements are consolidated, are available at its registered office, 100 Queen Street, Glasgow, G1 3DN.
