The main focus of the Arran Theatre and Arts Trust since the McLellan Centenary Festival in 2007 has been to promote new work by Scottish poets and playwrights through the McLellan Awards for Poetry and Play Writing and to continue to develop new work in the performing and visual arts on the Isle of Arran with particular reference to young people.

Report on Annual Activities, 2013 - 14

The work of 2013/2014 concerned mainly the organising and running of the McLellan Arts Festival and associated events, administering Arran Arts Resource, completing the Arran Film Project and the Gaelic Project.

Arran On Film Project

This project concluded in 2013 with local film maker, Ed O'Donnelly collecting and saving archive film of Arran as well as interviewing, as an additional archive, local people about the content and era of the films as they remember it. This has also resulted in a beautifully crafted compilation of archive footage from the 1920s to the 1970s, including, one hundred still photographs, many of which have never been shown before. As part of the McLellan Arts Festival, Corrie Hall was again the venue for this hugely popular event stirring memories and providing an insight into Arran's past. (DVD available)

Gaelic Project:

This was instigated by North Ayrshire Council, led by Arran Arts Resource and Sheila Blain and was completed this year. Its purpose was to raise cultural awareness of the place of Gaelic in Arran's heritage amongst all primary school children and focused largely on place names and their meanings in the changing landscape of the island.

Arran Open Studios

The second Arran Open Studios event took place over 4 days, August $16^{th} - 19^{th}$ 2013. Thirty-five of Arran's artists and craft workers opened their doors to allow members of the public to see where and how they work, to watch artists, to discuss art, and to buy and commission work.

All the participating artists were featured in a brochure/ map which helped to guide visitors to the studios and also offered information on the artists and their recommendations of places to visit. A new feature this year was an artbus providing transport from the ferry and all around the island to the studios and craft workshops, also a new development.

The feedback from both artists and visitors was again very positive. Many artists were pleasantly surprised at the number of visitors and the level of their interest both from on and off the island. They were also pleased that they sold much more than they had expected.

We are currently engaged in seeking funding for next year's event.

McLellan Arts Festival 2013:

Drama

This year Robert McLellan's play The Carlin Moth was performed as part of the McLellan Arts Festival. This play, containing some of McLellan's most lyrical and descriptive scots, is a poignant fairy tale set on Arran. It is a challenging piece, both because of the language and of the technical demands of lighting. Once again through the accomplished direction of John Sillars, the technical expertise of Arran Events, in the guise of Robin Fisher and Andy McCallum, the haunting music composed especially by Diana Hamilton and the assured acting of Donald McEachern, Ailsa McNicol, Katharine O'Donnelly and Ceile Swinton-Boyle, this was a very successful production.

Music:

A welcome new venture was a very successful concert held in the Community Theatre given by the renowned Euan Stevenson Trio with guest appearance by our local Jazz doyen, Joni Keen. This was well attended and the eclectic mix of classical, traditional jazz and new composition by Euan Stevenson was thoroughly enjoyed by all.

An important aspect of the visit of the trio was a very successful and worthwhile workshop for school pupils in collaboration with Arran High School music department and PT, David Lambert.

Poetry

This has been a very successful year for poetry at the McLellan Festival. A most successful Poetry Competition was run by Cicely Gill and David Underdown resulting in over 800 entries, the largest number to date. The poetry evening at the McLellan Festival was led by the competition judges, Anne and Peter Sansom who also presented the McLellan Poetry awards, five of whom were present, one coming from New York. After the adjudication, the judges read the winning pieces and this was followed by the winners reading their own work again for the audience. This allowed for a greater understanding of the pieces and enjoyment of the event. The following day, Anne and Peter Sansom led a very successful, stimulating and helpful workshop in Corrie Hall attended by fifteen poets, mostly from the island.. The Festival was fortunate in financing this event through the Scottish Community Fund.

McLellan Festival Ceilidh:

Arran's own extraordinary depth and breadth of talent was again on show at the well-attended ceilidh at Corrie Hall. Hosted and ably led by Stuart Gough, the gathering of visitors and Arran folk danced the night away and was wonderfully entertained with piping from Sam Easson, an extract from McLellan's Arran Burn superbly read by John Sillars, beautiful songs from singing group, Vivace, powerful songs from Tim Pomeroy, and a tremendous session from the Arran Jazz Café Band which had the whole room jumping. With a splendid feast on top this was, again, a ceilidh to remember.

Arran Summer Music School:

Once again, Arran Theatre and Arts Trust worked in collaboration with Peter Alexander Wilson, teacher at the Royal Northern College of Music, Manchester in order to run a week long Summer School for talented music students. As a result of sponsorship from Auchrannie Resort and the generosity of local residents, three teachers and three accompanists were brought to the island to provide expert tuition for twelve young people, undergraduate and post-graduate students at Royal Northern College. Not only did the young people enjoy first class tuition but provided the island with outstanding performances on the Friday and Sunday evenings of the Festival. The students also contributed beautiful music to a church service held in Corrie Church - a special McLellan Festival service – during which John Sillars also read one of Robert McLellan's stories with great skill and humour.

The partnership with Peter Alexander Wilson continues to be most successful and one which we all would wish to repeat if funding becomes available.

Summer School Gala Concert:

As last year, students from the Royal Northern College of Music took part in a Masterclass Course with their tutors, hosted by the McLellan Arts Festival. On Friday night these amazingly talented young performers took to the stage at Arran's Community Theatre with a Gala Concert that was simply stunning. Their voices were truly exceptional and the packed audience was enthralled by performances that brought out the humour, pathos, tenderness and romance from a wonderful programme of opera and musical theatre favourites.

Mendelssohn's Elijah

This year's oratorio took place in the Community Theatre on the second Sunday evening of the Festival. This event again brought together the summer school music students and local choral singers for a rousing rendition of Elijah. With only limited time for rehearsals the singers fused beautifully under the benign baton of conductor, Alexander Crowe resulting in the best performance to date of the community oratorio.

Film

A new venture this year was including a Scottish Film in conjunction with Corrie Film Club in the programme. The choice was Ken Loach's The Angel's Share and it proved a popular choice with a packed audience in Corrie Hall. This will be a continuing feature of the festival.

Funding 2013

Without support of our generous funders, the McLellan Festival would not take place. So, our thanks must go to: North Ayrshire Council for their continuing support contributing to the Young Person's Film Project, Open Studios and The Gaelic Project and, through the NAC Community Development Fund, to the workshops given by the Stevenson Trio and to the play production; Foundation Scotland for the Poetry Competition, Performance and Workshop; Hugh Fraser Foundation for general support; Auchrannie Resort for sponsorship of the Summer Music School and music events. We also gratefully acknowledge the Scottish Lottery Heritage Fund for supporting Arran on Film. The McLellan Festival acknowledges its debt to all these organisations and to the hard work and support of the Steering Group and Arran community.

Creative Places Award

In January 2014, Arran Theatre and Arts Trust in collaboration with other arts groups on the island applied for consideration of the Creative Places Award run by Creative Scotland. This involved a detailed application and then the making of a 10 minute film to illustrate the scope of the arts on the island. In fact, Arran became on of the 3 finalists in the competition losing only by a hair's breadth to Peebles. This was a most worthwhile experience and has helped us in the months since then to consider the future of the arts on the island including the setting up of an arts hub and investigating the possibility of having professional arts administration.

Publication of Collected Works of Robert McLellan

An important aspect of this year's work has been the publication and launch of the long-awaited Collected Works of Robert McLellan. This collection, called Playing Scotland's Story has been published by Luath Press, expertly edited by Colin Donati and containing all the works which Robert McLellan wanted published including all the previously unpublished works. The book was successfully launched at the Netherbow in Edinburgh with contributions by James Robertson. Professor Douglas Gifford and Donald Campbell with readings from members of Thetre Alba. This is a significant addition to the dramatic literature of Scotland and we are grateful to the Lottery Heritage Fund for making it
