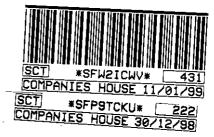

- 1) ACCOUNTING POLICIES:
 - THE ACCOUNTS ARE PREPARED UNDER THE HISTORICAL COST CONVENTION.

 STOCKS ARE VALUED AT COST.
- 2) STOCK, REPRESENTS BOOKS NOT YET SOLD.
- 3) LAND AND BUILDINGS:

THE TITLE TO THE LAND AND BUILDINGS IS HELD IN THE TRUSTS NAME AND REPRESENTS THE CHURCH.

4) DIRECTORS LOAN ACCOUNT:

THE LOANS FROM THE DIRECTORS HAVE NO FIXED TERM FOR REPAYMENT AND NO INTEREST WAS CHARGED DURING THE YEAR.
