The principal terms on which the assistance will be given are:-

- (i) under the Facilities Agreement, the Company unconditionally guarantees the payment or discharge of the Guaranteed Liabilities (as defined in the Facilities Agreement) owing by the Company and each other member of the Group pursuant to the Finance Documents (as defined in the Facilities Agreement);
- (ii) under the Intercreditor Agreement, the interrelationship between the Guaranteed Liabilities referred to at paragraph (i) above are regulated;
- (iii) under the Floating Charge, the Company charges the whole of its property, undertaking and assets in favour of the Bank in its capacity as Security Trustee to secure the Secured Liabilities;
- (iv) under the Standard Security, the Company charges to the Bank in its capacity as Security Trustee its heritable interest in the property known as Stratton Lodge Hotel, Inverness to secure the Secured Liabilities;
- (v) the Company agrees in terms of the Funding Agreement, subject to the satisfaction of certain conditions, to lend funds to the Purchaser on the terms set out therein in order to enable the Purchaser *inter alia* to discharge its obligations under the Finance Documents (as defined in the Facilities Agreement) and to make certain other payments; and
- (vi) the Purchaser agrees in terms of the Support Agreement, to lend funds to the Company on the terms set out therein in order to enable the Company *inter alia* to discharge its obligations to the Funding Parties (as defined therein).

Where:-

"Group"

means the Purchaser and each of its subsidiaries from time to time; and

"Secured Liabilities"

means all present and future liabilities and obligations (whether actual or contingent and whether owed jointly or severally or in any other capacity whatsoever) which now or hereafter may be or become due and owing by the Company to any Secured Party (as defined in any relevant Finance Document) under the Relevant Documents (as defined in any relevant Finance Document) and references to Secured Liabilities includes references to any of them.

INDEPENDENT AUDITORS' REPORT TO THE DIRECTORS OF MACDONALD HOTELS AND RESORTS LIMITED ("THE COMPANY") PURSUANT TO SECTION 156(4) OF THE COMPANIES ACT 1985

We have examined the attached statutory declaration of the directors of the Company dated 19 October 2005 in connection with the proposal that the Company should give financial assistance for the purpose of reducing or discharging a liability incurred in connection with the acquisition by Macdonald Hotels Limited of 63,370,864 ordinary shares of £0.05 each in the share capital of the Company.

This report is made solely to the directors of the Company for the purpose of section 156(4) of the Companies Act 1985. Our work has been undertaken so that we might state to the directors of the Company those matters that we are required to state to them in an auditors' report under that section and for no other purpose.
