# Notes on the Financial statements for the year ended 31 March 2018

### 1 Significant accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

### **Basis of preparation**

SSE Group Limited (the "Company") is a company limited by shares and incorporated and domiciled in the UK.
