1. Introduction

Shona Campbell of Henderson Loggie, The Vision Building, 20 Greenmarket, Dundee, DD1 4QB was appointed as Provisional Liquidator of Quality Scotland Foundation by the Sheriff of Lothian and Borders at Edinburgh Sheriff Court on 4 November 2020 following presentation of a petition by Quality Scotland Foundation on 4 November 2020.

Shona Campbell of Henderson Loggie, The Vision Building, 20 Greenmarket, Dundee, DD1 4QB was then appointed as Interim Liquidator of Quality Scotland Foundation by the Sheriff of Lothian and Borders at Edinburgh Sheriff Court on 2 December 2020.

As no nominations were received regarding the appointment of the Liquidator, a Note was submitted to Edinburgh Sheriff Court seeking the appointment of Shona Campbell as Liquidator and this was granted on 2 March 2021.

Shona Campbell is the Liquidator of the Company, and this is her report to the creditors showing how the liquidation has been conducted for the above period. The report covers in summary the whole period of the liquidation to date.

2. Statutory Information

Statutory information relating to the Company is attached at Appendix I.

3. Liquidator's Receipts and Payments Account

A summary of the Liquidator's receipts and payments account for the relevant period from 4 November 2021 to 27 April 2022, and cumulatively (from commencement of liquidation on 4 November 2020 to 27 April 2022) is attached at Appendix II.

4. Action taken by the Liquidator

Furniture and Fittings

As previously advised, the company's assets were sold at auction and net proceeds of £1,931.90 were paid to the landlord in terms of the landlord hypothec.

Book debts and VAT bad debt relief

Efforts to ingather the sums due to the Company regarding membership fees and services provided to customers have been exhausted. No further action is required in this regard.

The final Form VAT426 will shortly be submitted to HMRC. The amount being reclaimed will settle the balance of fees due to the Liquidator.

Cash at Bank and in hand

The company bank account was closed with the balance of funds held being paid to the liquidation in November 2020.

Insurance Refund

Funds totalling £591.19 were received in respect of a refund of death benefit policy held by the company.

All assets have now been realised.

Third Party Funding

These monies were provided to settle the petitioning costs of the liquidation.

Investigations

The Liquidator has a duty to submit confidential reports to the Insolvency Service Disqualification Unit on the conduct of those persons who acted as directors of the company in the three-year period before the liquidation. I can confirm that I have complied with my duties in this regard.

As previously advised, there are no outstanding lines of enquiry.

5. Liabilities and Dividends

Secured creditors

There were no secured creditors.

Preferential creditors

No claims have been received to date. It is estimated that sums due to the Redundancy Payments are £6,921.05 and employees have preferential claims totalling £1,600.58. As there were insufficient realisations to meet the Liquidator's fees and other administrative costs of the liquidation in full, there was no dividend payment to any class of creditor in this case.

Floating charge creditors and Prescribed Part

As there was no qualifying floating charge in this case, the prescribed part provisions did not apply.

Ordinary creditors

Claims totalling £62,924.20 have been received from fourteen creditors, which is lower than the anticipated creditors of £216,876.00. Of the £37,067 estimated to be due to employees in respect of redundancy and notice pay only one claim has been received in the sum of £3,697.98. No claim has been received from HMRC.

No dividend has been paid to ordinary creditors because there were insufficient realisations to meet the Liquidator's fees and other administrative costs of the estate.
