





- 4. The directors are unconditionally authorised for the purpose of Section 80 Companies Act 1985 to allot relevant securities up to the amount of the share capital of the Company created on incorporation of the Company at any time or times during the period of five years from the date of incorporation of the Company and Section 89(1) shall not apply to any allotment authorised as aforesaid
