#### 1. Introduction

Michael James Meston Reid CA, Meston Reid & Co, 12 Carden Place, Aberdeen, AB10 1UR was appointed administrator of JKM Property Services Limited "JKM" by its directors. Such appointment was ratified by the court of session on 19 October 2011.

In accordance with rule 2.38 of The Insolvency (Scotland) Rules 1986, the administrator sets out below his report to the creditors of JKM in respect of the first six months of the process.

## 2. Summary of administrator's proposals

The administrator's proposals which were sent to creditors on 8 December 2011 comprised:

- (a) Progress book debt collections with a view to collecting all outstanding monies due to JKM in respect of invoices issued and contract payment applications submitted, and complete any ongoing contract work in order to issue sales invoices.
- (b) Monitor completed contracts with a view to collecting retention monies due.
- (c) Undertake all duties and exercise such powers as may be required in order to achieve the purpose of the administration.
- (d) Settle all valid administration outlays. In this regard, if there be any unpaid costs of the administration at conclusion of the process, they will be given priority over the costs of any subsequent insolvency procedure that may arise.
- (e) Seek an extension of the administration period if deemed necessary by the administrator in accordance with paragraphs 77 and 78 of schedule B1 of the Insolvency Act 1986.
- (f) Once the monies available have been distributed to creditors in accordance with their legal ranking, file a notice with both the court and the registrar of companies in order that the process can conclude.
- (g) Apply to court seeking an order in terms of section 65 of schedule B1 of the Insolvency Act 1986 allowing the administrator to pay a distribution to unsecured creditors (if applicable).
- (h) Should creditors deem it appropriate, the process will move from administration to liquidation following the initial meeting of creditors in the form of a creditors voluntary liquidation in accordance with section 83(2) of schedule B1 of the Insolvency Act 1986 or compulsory under Rule 4.7(7) of the Insolvency (Scotland) Rules 1986 as the administrator shall deem appropriate. The administrator will continue in office as liquidator should liquidation proceedings ensue.
- (i) The administrator's remuneration be fixed on the basis of time, cost and outlays properly incurred by him and his staff in attending to matters arising in the insolvency in accordance with Statement of Insolvency Practice 9 "SIP9".

#### 3. Progress report

#### Book debt collection

Book debts recorded in the JKM records as at 19 October 2011 totalled £537,988 and to date, £246,812 has been recovered.

Full recovery of the balance is not anticipated due to various issues that have been brought to the administrator's attention and therefore a provision of approximately 50% has been made for potential bad or doubtful debts. This leaves an estimated recoverable balance of £150,000.

## Work-in-progress

To date £143,375 has been invoiced and £17,553 collected. Further sales invoices will be issued shortly for about £25,000. In light of customer representations received to date, a recovery of approximately 30% of the original figure is believed to be realistic.

## Retentions

Retentions recorded in the JKM records totalled £30,462 as at the date of administration. It is anticipated that recovery from retentions will be less than anticipated because some contracts were not completed and various snagging issues have been highlighted. Based upon customer responses to date, £7,615 is likely to be recoverable.

Enquiries have revealed that JKM are due retentions for a number of jobs performed for a large customer. Total retentions approximate £40,000 and should be paid periodically until October 2013. Full recovery is unlikely because there have been various issues with jobs and the cost of remedial work will be deducted from the retentions.

The recovery process for book debts, work in progress and retentions has been progressed with assistance from former JKM personnel and other appropriate professional advisors.

## Floating charge holder

A floating charge was created in favour of Bank of Scotland on 11 September 1996 and registered on 23 September 1996. The bank has submitted a claim of £381,639.78.

Since the onset of administration proceedings, monies were lodged by some customers in the JKM bank account. It has been agreed with the bank that when the sum has been quantified and agreed, such lodgements can be retained by the bank and treated as a first interim dividend. Initial investigations suggest this sum to be £99,281 (book debts and work in progress invoices collected by the bank) less £16,446 that reverted to the administrator in respect of post-appointment invoices. This will be subject to formal agreement between the bank and the administrator in due course.

## 5. Receipts and payments account

The administrator's receipts and payments account in respect of the six month period from 19 October 2011 (date of administration) to 18 April 2012 is attached: appendix 1.

## 6. Claims and dividend prospects

From review of the claims received, £71,340 is likely to be afforded a preferred ranking, £381,639.78 falls to be dealt with under the bank's floating charge, and the balance will be unsecured.

A schedule detailing unsecured claims received to date is attached to this report: appendix 2. Where the administrator's records indicate that a creditor has not yet submitted a claim, a claim form is enclosed with this report for completion and return to the administrator, together with supporting documentation.

## 7. Administrator's fee claim

On 9 January 2012 a letter was sent to all known creditors with information regarding the administrator's remuneration for the period 19 October 2011 (date of administration) to 22 December 2011 (date of initial meeting of creditors). No objections were received in the prescribed 14 day period and the remuneration was settled from administration funds available.
