Prescribed particulars	The Ordinary shares carry the right to receive notice of, attend and vote in person or by proxy, or if a corporation, by a duly authorised representative, at any general meeting of the Company on the basis of one vote for each Ordinary share held. On winding up or return of capital, the surplus assets of the Company, after paying all the debts and satisfying all the liabilities of the Company, shall be distributed to the holders of the Ordinary shares pro rata according to the nominal capital paid up on their holdings of Ordinary shares. Subject to the rights of persons entitled to shares with any priority, preference or special rights as to dividend, all dividends shall be declared and paid according to the amounts paid up on the shares in respect whereof the dividend is paid. All dividends shall belong and be paid (subject to any lien of the Company) to those members whose names shall be on the Register at the date at which such dividend shall be declared or at such other date as the Company by ordinary resolution may determine. Any general meeting declaring a dividend may, upon the recommendation of the Board, direct payment of such dividend wholly or in part by distribution of specific assets and in particular of paid up shares or debentures of any other company. If the Company shall be wound up (whether the liquidation is voluntary or by the Court) the liquidator may, with the authority of a special resolution, divide among the members in specie or kind the whole or any part of the assets of the Company.
