1. Accounting policies

1.1 Basis of preparation of financial statements

The Woollen Mill Limited (the "Company") is a private company incorporated, domiciled and registered in the UK. The registered number is SC153051 and the registered address is Waverley Mill, Langholm, Dumfriesshire, DG13 0EB.

These financial statements are drawn up for the 27-week period ended 2 March 2019. The comparative figures are for the 78-week period ended 25 August 2018.
