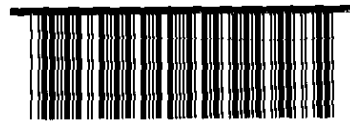

For the purposes of paragraph 24 of Schedule 8 to the Companies Act 1985

I have examined the abbreviated accounts on pages 4 to 6 together with the full financial statements of Lairdmount Limited for the year ended 30 April 2001. The scope of my work for the purpose of this report was limited to confirming that the company is entitled to deliver abbreviated accounts and that the abbreviated accounts have been properly prepared from the full financial statements.

Basis of opinion

These procedures provide only the assurance expressed in my opinion.

- b) having regard only to, and on the basis of, the information contained in those accounting records :

 - (ii) the company satisfied the conditions for exemption from an audit of the accounts for the year specified in section 249A(4) of the Act and did not at any time within that year, fall within any of the categories of companies not entitled to the exemption specified in section 249B(1)

1. ACCOUNTING POLICIES

(a) Basis of preparation

The accounts are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective March 2000).

(b) Fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets over their anticipated useful lives at the following annual rates :

Motor vehicle	25% reducing balance
Computer systems	33 1/3% reducing balance
Equipment	20% reducing balance
