

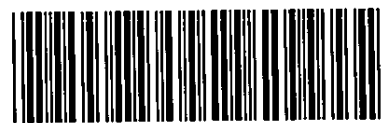

### **Report of the Directors**

The Directors present their report together with the audited financial statements for the year ended 31 March 2012.

#### **1. Principal Activities**

The Company's principal business is a ceased leasing trade holding legacy balances.

#### **2. Business Review**

The Company's main purpose was to enter into leasing arrangements associated with the electricity business of its parent company, Scottish and Southern Energy plc.

As a result of the early settlement, the company no longer has any finance leases in which to lease, the only financial transactions.

As in the prior year the directors do not intend to acquire a replacement trade and have therefore not prepared the financial statements on a going concern basis. The effect of this is explained in Note 1.

#### **3. Results and Dividends**

The profit for the financial year amounted to £31k (2011 - £nil). The Directors do not recommend the payment of a dividend (2011 - £nil).

They have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the company and to prevent and detect fraud and other irregularities.

- have been prepared in accordance with the requirements of the Companies Act 2006.


#### **Opinion on other matter prescribed by the Companies Act 2006**

### **Notes on the Financial statements for the year ended 31 March 2012**

#### **1. Significant accounting policies**

##### **Basis of preparation**

The financial statements have been prepared in accordance with all applicable United Kingdom accounting standards. The principal accounting policies are summarised below and have been applied consistently.

In previous years, the financial statements have been prepared on a going concern basis. However during the prior year the directors took the decision to cease trading following the early settlement of the finance leases for the Oldham and Watford colour print plants. As they do not intend to acquire a replacement trade, the directors have not prepared the financial statements on a going concern basis. No adjustments were necessary to the amounts at which the remaining net assets are included in these financial statements.

Under Financial Reporting Standard 1 (FRS 1), the Company is exempt from the requirement to prepare a cash flow statement on the grounds that the ultimate parent undertaking includes the Company in its own published consolidated financial statements.

As the Company is a wholly owned subsidiary of SSE plc, it has taken advantage of the exemption contained in FRS 8 and has therefore not disclosed transactions or balances with entities which form part of the SSE Group (the Group).

##### **Turnover**

Turnover represents the amounts (excluding value added tax) derived from the provision of lease finance to customers.

##### **Finance Leases**

Finance lease income is allocated to accounting periods so as to give a constant rate of return on the net cash investment in the lease. The total net investment in the finance leases included in the balance sheet represents total lease payments receivable net of finance lease income relating to future accounting periods.

##### **Taxation**

The charge for taxation is based on the profit for the year and takes into account deferred taxation.

Current tax, including UK corporation tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted, or substantially enacted, by the balance sheet date.

Deferred taxation arises in respect of items where there are timing differences between their treatment for accounting and taxation purposes. This is recognised where an obligation to pay more tax in the future has originated but not reversed at the balance sheet date. A deferred tax asset is recognised only when it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

#### **2. Directors', staff and auditors' remuneration**

No Director received remuneration in respect of their service to the Company (2011 - £nil). There were no staff employed during the year (2011 - nil). The audit fee for these Financial statements were borne by the ultimate parent company (2011 - £nil).

A reduction in the rate from 26% to 25% (effective from 1 April 2012) was substantively enacted on 3 July 2011, and further reductions to 24% (effective from 1 April 2012) and 23% (effective from 1 April 2013) were substantively enacted on 26 March 2012 and 3 July 2012 respectively.
