Purpose

- > To support Gaelic authors by awarding grants and commissions.
- > To support the Gaelic publishing industry.
- > To increase the range, quality and impact of Gaelic literature.

Comhairle nan Leabhraichean / The Gaelic Books Council is a charitable company limited by guarantee and is governed by its Memorandum and Articles of Association dated 2 July 1996 and updated on 23 February 2011.

Funding

The Gaelic Books Council has two main funding bodies.

- > Creative Scotland The Gaelic Books Council is one of Creative Scotland's Foundation Funded Organisations.
- Bòrd na Gàidhlig The Gaelic Books Council is one of Bòrd na Gàidhlig's key delivery agents. In addition to its core responsibilities for literature, the Gaelic Books Council also administers third party grant funds to Acair Ltd and manages the corporate finances of An Lèanag, the Gaelic development hub in Glasgow on behalf of Bòrd na Gàidhlig.

The Council and its Members

The directors of the charitable company Comhairle nan Leabhraichean / The Gaelic Books Council are its Trustees for the purpose of charity law and throughout this report are collectively referred to as the Trustees.

Trustees are invited to apply for the position through national advertisement and are selected by the Chair and Director on the grounds of their ability to advise staff on how best to progress the work of the charity.

Trustees are appointed for three years, in the first instance, but may serve for a further two years if that is mutually agreed. With the exception of the Chair, who is awarded an annual honorarium in recognition of the additional responsibilities associated with this role, Trustees are unpaid and receive only travel and subsistence expenses.

Council / Board meetings are held four times a year, in line with Creative Scotland and Bòrd na Gàidhlig guidelines. A sub-committee (Grants Committee) meets four times a year to respond to applications from authors and publishers for grants and commissions. While there is no formal Audit or Remuneration Committee in place, the Trustees conduct an annual salary review, in line with the Scottish Government's Pay Policy, and the company finances are reviewed at the board meetings.

Meetings called by external agencies are normally attended by staff, but the Chair and Trustees may be required to attend when it is appropriate.

The Chairman's Introduction

2012-13 has been a year of financial stability for the Gaelic Books Council. The organisation has turned around a deficit in 2011 to a reasonable surplus in 2012 and now in 2013. This stronger financial footing has generated renewed confidence and affords the organisation the opportunity to consider new developments while maintaining a clear focus on core activities — the support of Gaelic authors and publishers and the encouragement of new Gaelic writers.

Collaborative working is very much a focus for the Books Council and we are working in partnership with a wide range of organisations in Scotland and beyond in order to develop and promote Gaelic writing. At home in Scotland, key relationships have been established with the Scottish Poetry Library, Scottish Book Trust and Glasgow Life. Effective partnerships have long existed between the Gaelic Books Council and the Gaelic publishers. Acair has secured a significant contract for the development of new Gaelic contemporary fiction, while block grant arrangements have been agreed with Clàr, Leabhraichean Beaga and Spòrs. The Books Council will continue to investigate ways to support Gaelic publishers.

The staff of the organisation have worked hard to implement and refine new policies for commission and publication grants, with greater clarity on eligibility criteria and timeframes for response. Despite the economic downturn, the sales and marketing strategy, together with the redevelopment of the organisation's website, has recorded modest increases in online sales. Special promotions and targeted marketing through social media will be employed in an effort to drive up sales, with a heightened emphasis on outreach sales events. Strategic literary events, in collaboration with publishers, have continued to showcase the work of Gaelic writers and attendance at these events has been consistently high. Additionally, we have re-vamped the shop to create a flexible space that is first and fore-most, a sales outlet, but can also be used for book launches and other related activities.

I am particularly proud of the hard work and dedication that staff have shown in the last twelve months and look forward to another productive year in which the Books Council continues to play a pivotal role in supporting Gaelic writing, authors and publishers.

The Director's Report

Greater financial stability in 2012-13 afforded the Gaelic Books Council the freedom to redevelop the company website, to make improvements to the bookshop and to develop the organisation's digital strategy. The new website carries information on new Gaelic publications, book reviews, relevant news items, details of forthcoming events, and policy statements, as well as a new, user-friendly, online shopping facility. Social media has been exploited to raise awareness of the work of the organisation and to market new Gaelic publications.

Publication grants and commissioning procedures continued to be refined and implemented by John Storey with administrative support from Mairi MacCuish. In 2012-13, a total of 29 individual applications were approved and responded to within the designated timeframes, resulting in a more effective partnership between the Gaelic Books Council and Gaelic writers and publishers.

The Gaelic Books Council's ongoing collaboration with Scottish Book Trust, to identify and support new writers through the annual Gaelic New Writers Awards scheme, continues to source new and imaginative Gaelic writers. To date, eight new writers have benefited from the award and the associated training opportunities. The Books Council is currently investigating the possibility of extending this partnership to include a Gaelic award within Scottish Book Trust's Young Writers Awards.

The Gaelic Books Council's collaboration with the Scottish Poetry Library was further developed in 2012-13 with the continued sponsorship of a Gaelic poetry postcard, as part of the set of eight issued to all schools and libraries to mark National Poetry Day in Scotland.

Eleven strong applications were received for the Gaelic Books Council's prestigious annual literary prize, The Donald Meek Award 2012. This was an increase on the previous year and illustrates the growing confidence of Gaelic writers in showcasing their own talent. Moray Watson was the recipient of the 2012 Donald Meek Award for his poetry anthology, *Iain Mac a' Ghobhainn – A' Bhàrdachd Ghàidhlig, the collected poems of Iain Crichton Smith.* The shortlist and announcement of the winner of this award continues to be showcased at the Edinburgh International Book Festival in August each year.

The Gaelic Books Council's flagship literature development initiative, Ùr-Sgeul, has published more than 30 new Gaelic fiction titles since its inception in 2003. This project has been one of the most important developments in Scottish literature in recent times and has helped to create a significant network of new and exciting Gaelic writers. In March 2013, the Gaelic Books Council marked ten years of Ùr-Sgeul at *Leabhar 's Craic*, the annual Gaelic literary festival, hosted in collaboration with Glasgow Life and Ceòl 's Craic. The contract for the continued development and publication of a series of new contemporary Gaelic fiction for adults was awarded to Acair Ltd, the Stornoway based publisher. Acair has developed a new imprint, Aiteal and spent much of 2012-13 securing new commissions, developing their design concept and co-ordinating their publication schedule. The first publication in this new series will be launched at the Edinburgh International Book Festival in August 2013.

The Gaelic Books Council continued to promote Gaelic literature and books at a range of local and national literary events and book launches. In spite of the difficult financial climate, the Gaelic Books Council realised relatively healthy sales figures, largely due to the sales and marketing strategy and the heightened use of social media. In October 2012, Shelagh Campbell left the organisation to take up a new training opportunity. The Gaelic Books Council is indebted to Shelagh for her hard work and commitment and we wish her every success in her new venture. Maria MacInnes was appointed to the post of Sales and Marketing Officer in November 2012 and she immediately set about redeveloping the company website and implementing the digital strategy. Sales in the bookshop were coordinated by John N MacDonald, the Sales and Finance Officer. In addition to local book sales and launches, Gaelic publications were showcased at Edinburgh International Book Festival, Leabhar 's Craic, Imprint, Aye Write and the Royal National Mod.

The Gaelic Books Council would like to thank Creative Scotland and Bòrd na Gàidhlig for their continued support and investment.

Towards the end of the financial year, the Gaelic Books Council was deeply saddened by news of the sudden and untimely death of Dr. Gavin Wallace, Portfolio Manager for Literature at Creative Scotland. Gavin was a great supporter of the Gaelic Books Council and the organisation benefited greatly from his sound advice, his cheery disposition and his remarkable knowledge and love of Scotlish literature. Gavin was instrumental in securing support for a wide range of Gaelic Books Council initiatives and his passing leaves a huge void.

In conclusion, I am deeply indebted to the Chair and Trustees of the Board of the Gaelic Books Council for their willingness to give of their time to support the work of the organisation. The Board underwent changes in 2012-13 with the resignation of four members in June 2012 and the appointment of their replacements in September 2012. I would also like to thank my small but highly effective team of staff who work tirelessly to respond to the needs and responsibilities of the organisation. Going forward, the Gaelic Books Council plans to build on current successes, invest in the Gaelic publishing industry and identify new opportunities and initiatives to promote Gaelic literature and Gaelic books to a new generation of readers.

Publication and Commission Grants

In 2012-13, the new procedures for the administration of publication and commission grants were reviewed and refined. Grant applications are invited on a quarterly basis with a timeline for submissions prominently advertised on the company's website. All applications are dealt with within a designated timeframe.

The Literature and Publishing personnel within the Gaelic Books Council are responsible for administering publication and commission grants. A Grants sub-committee meets four times a year to assist staff in responding to applications for grants and commissions from authors and publishers. Funds are awarded to support the publication of Gaelic-only and bilingual books.

In 2012-13, the Board approved the allocation of block grants of £10,000 to Clàr and £8,000 to Leabhraichean Beaga and Spòrs as part of our investment programme in Gaelic publishing. This funding provides a degree of security to small, fragile Gaelic publishers and enables them to plan a more detailed publishing programme. These funds were allocated from the budget of £88,000 designated for grants and commissions. The grants programme supports the commissioning and publication of a variety of books for leisure reading, specifically for young children, teenagers and adults. The Gaelic Books Council reserves the right to review the priority genres for publication and commission grants on an annual basis.

Commissioned authors usually have a period of two years from the date of signing their commission agreement, to submit their completed manuscript. Publishers can apply directly to the Gaelic Books Council for funds to enable them to commission new and original publications.

A total of 27 publication grant applications were received in 2012-13. 19 individual publication grants were approved. A total of 17 commission grant applications were received and 10 individual commission grants were approved in 2012-13.

Contemporary Fiction / The Next Phase

2013 marks ten years of Ùr-Sgeul, the highly successful Gaelic fiction imprint published by Clàr, the Inverness based publisher. Over the last decade, 33 titles have been published - 24 novels and novellas, and 9 short story collections. The final title in this series, *Màiri Dhall agus Sgeulachdan Eile* by Duncan Gillies, will be published in June 2013.

The annual Gaelic literary festival, Leabhar 's Craic paid tribute to 'Ùr-Sgeul - The Legacy', in March 2013 and the imprint will also feature in the Edinburgh International Book Festival programme in August 2013 with an event chaired by Dr. Moray Watson. The Gaelic Books Council is confident that Ùr-Sgeul has provided a strong model for the sector to expand and flourish. Going forward, 2013 -14 brings with it an exciting new development for Scottish Gaelic fiction, in the form of Acair's Aiteal series, which builds on the foundations of Ùr-Sgeul. The first title in this new series will be launched at the Edinburgh International Book Festival in August with Andrew Dunn reading from his debut novel, *Còisir nan Gunna*.

Education / Writers in Schools

Education remains an important element of the Gaelic Books Council's work. Exposure to Gaelic literature and advice and support from established Gaelic writers is critical in laying foundations for young writers of the future. Creative writing workshops were delivered in schools across Argyll and Bute and the central belt of Scotland during 2012-13. Pupils were given the opportunity to work with writers who had recently published new works. The writers were encouraged by the enthusiasm and interest shown by the pupils in all the schools they visited.

Sales and Marketing

Given the difficult economic situation, it would appear that the organisation was rather unrealistic in the projections made regarding the income that might be generated from the sale of books. The actual income from sale of books fell short of the projected target. The redevelopment of the company website and the heightened focus on online sales will hopefully increase sales in 2013-14. There is no doubt that the new website and the increased use of social media such as Facebook and Twitter will help to promote sales initiatives and events. The redevelopment of the bookshop and the fact that the retail space can now be more effectively used for book launches, reading sessions and social events should also help to drive up sales in the coming year.

A number of promotional campaigns have been offered to customers both in store and online, including a Winter Sale, multi-buy offers and competitions to win tickets to Gaelic events at literary festivals.

The Gaelic Books Council's sponsorship and marketing fund continues to attract a healthy number of applications from a wide range of publishers seeking to secure funding to support Gaelic literary events, book launches and marketing initiatives. This fund specifically targets small Gaelic publishers to help them promote and market their products.

Financial Review

The results for the year are set out in the Statement of Financial Activities on page 15. The charity made a surplus of £24,589 for the year (2012: £33,489) and has funds carried forward at 31 March 2013 of £69.134.

Principal Funding Sources

The charity has two main funding sources, Creative Scotland and Bòrd na Gàidhlig. The monies from these bodies are in the form of revenue grants.

Reserves Policy

The Board adopted a formal reserve policy:-

- To provide six months charitable running costs with a target date of 10 years. At current levels of
 expenditure this would equate to £200,000. This will be to cover staff costs, rent, communications,
 postage & carriage and other liabilities of the key projects being delivered by the Gaelic Books
 Council.
- Currently, reserves stand at £40,825 which is below the targeted level.

Plans for Future Periods

In 2012-13, the Gaelic Books Council funded the publication of *Màiri Dhall agus Sgeulachdan Eile*, the final title in the hugely successful Ùr-Sgeul imprint which was developed by the Gaelic Books Council and published by Clàr over a ten year period. Acair, the Stornoway based publisher, will publish new Gaelic fiction under the name of Aiteal, a new series that will build on the legacy of Ùr-Sgeul and will seek to support existing and new Gaelic writers in producing innovative, contemporary fiction. The Head of Literature and Publishing at the Gaelic Books Council will liaise closely with Acair to provide appropriate advice and guidance on the publication of four new Aiteal titles in 2013-14.

The Gaelic Books Council will maintain block grant support to Clàr, Leabhraichean Beaga and Spòrs in 2013-14, and will continue to investigate how best to support other small, Gaelic publishers to plan and deliver enhanced publication programmes.

The development of pupils' writing skills and their appreciation of Gaelic literature remains an ongoing priority for the Gaelic Books Council. A programme of writing workshops in schools will continue in 2013-14 and the Gaelic Books Council will work in collaboration with Scottish Book Trust to establish a Gaelic Award in the national Young Writers Awards.

The Donald Meek Award for Gaelic literature remains an ongoing priority for the Gaelic Books Council and the organisation will continue to encourage and support new Gaelic writers to develop their creative skills and will maintain support for two Gaelic awards in the national New Writers Award Scheme.

Training will be offered to a small cohort of Gaelic editors and translators as a first step towards establishing an editorial unit to support Gaelic publishers with a range of editorial functions, including proof reading, content editing and the production of manuscript reports for unpublished material. A database of approved Gaelic editors will be produced and will be disseminated to Gaelic publishers to ensure that they are able to deliver a broad publishing programme within an acceptable timeframe.

Driving up sales of Gaelic books remains an ongoing priority and the Gaelic Books Council will continue to develop a comprehensive digital strategy and will exploit social media to market and promote new Gaelic publications, increase sales of Gaelic books and increase the incidence and reach of Gaelic literary events. The organisation will seek to extend existing cooperative working relationships with a wide range of national literary agencies.

Statement of Trustees' Responsibilities

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2013

1. Accounting Policies

a) Basis of preparation

The financial statements have been prepared under the historic cost convention and in accordance with the Statement of Recommended Practice – Accounting and Reporting by Charities (SORP 2005) issued in March 2005 applicable UK Accounting Standards and the Companies Act 2006. The principal accounting policies adopted in the preparation of the financial statements are set out below.

b) Taxation

The company is a charitable company within the meaning of Section 467 of the Corporation Tax Act 2010. Accordingly, the company is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 of Part 11 of the Corporation Tax Act 2010 and section 256 of the Taxation of Chargeable Gains Act 1992 to the extent that such income or gains are applied for charitable purposes only.

c) Fund accounting

- Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Designated funds are unrestricted funds earmarked by the Trustees for particular purposes.
- Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

d) Incoming resources

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included in these accounts.
- Donated items for resale are included at 50% of the anticipated sale price.
- Investment income is included when receivable.
- Incoming resources from charitable trading activities are accounted for when earned.
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2013

1. Accounting Policies (continued)

Income is only deferred when:

- The donor specifies that the grant or donation must only be used in future accounting periods; or
- The donor has imposed conditions which must be met before the charity has unconditional entitlement.

e) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered and is reported as part of the expenditure to which it relates:

- Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes.
- Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Grants in respect of the commission of new works are not recognised as a liability until the
 manuscript has been produced and approved by the council. Grants in respect of the
 publication of materials are awarded on condition that publication occurs within 12 months.
 Such grants are recognised as liabilities to extent that they are paid or expected to be paid
 within that timescale
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the external scrutiny fees and costs linked to the strategic management of the charity.
- All costs are allocated between the expenditure categories of the SOFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis.

f) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:

g) Stock

Stock is valued at the lower of cost and net realisable value. Items donated for resale are included at 50% or less of anticipated sale price.

h) Pension scheme
