

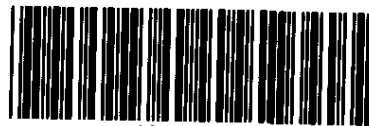

The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 24 July 2020 and the Metro newspaper dated 24 July 2020 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Envirosoil Technologies Limited paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts; therefore Orders that the said company, having its registered office at 20 Nasmyth Court Houston Industrial Estate, Livingston, EH54 5EQ be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Thomas Campbell MacLennan and Alexander Iain Fraser, Insolvency Practitioners of FRP Advisory, Apex 3, 95 Haymarket Terrace, Edinburgh, EH12 5HD to be joint interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
