"the Charge" means the standard security by the Chargor in favour of the Lender dated 10 February 2005 registered in the Land Register of Scotland under Title Number ELN9418 on 5 April 2005;

"Chargor" means the Scottish Seabird Centre, a company incorporated under the Companies Acts with registered number SC 172288 and having its registered office at Scottish Seabird Centre, The Harbour, North Berwick, East Lothian EH39 4SS;

"Lender" means the Millennium Commission, a body corporate established by Section 40 of the National Lotteries Etc Act 1993 and having its head office at 1 Plough Place, London EC4A 1DE;

"Secured Assets" means the subjects comprising ALL and WHOLE those subjects in the County of East Lothian comprising (One) the upper floor of the property formerly known as the Sun Pavilion, The Harbour, North Berwick, in the County of East Lothian being the subjects extending to one hundred and sixty five square metres and six decimal or one tenth parts of a square metre (165.6 square metres) or thereby all as shown hatched and cross-hatched in black and delineated in red on plan 1 annexed and executed as relative to the Charge; and (Two) the portion of the lower floor of the said property extending to one hundred and five square metres and four decimal or one tenth parts of a square metre (105.4 square metres) or thereby all as shown crosshatched in black and delineated green on plan 2 annexed and subscribed as relative to the Charge, which subjects form part and portion of ALL and WHOLE those subjects in the Burgh of North Berwick and the County of East Lothian forming part of the Estate of North Berwick, as more particularly described in and disponed by the Disposition by Sir Hew Hamilton Dalrymple, of North Berwick, Baronet, in favour of the Provost, Magistrates and Councillors of the Royal Burgh of North Berwick dated 19 and recorded in the Burgh Register of Sasines for North Berwick on 20, both days of May 1922; TOGETHER WITH so far as the Chargor is entitled under the lease between the Chargor and East Lothian Council dated 18 November 2004 and registered in the Land Register of Scotland under Title Number ELN9418 (One) the part of the said property hereby secured; (Two) the whole rights, common, mutual or otherwise effeiring to the said subjects; (Three) the whole fittings and fixtures in and upon the said subjects; and (Four) the Chargor's whole right, title and interest, present and future, in and to the said subjects; and

"Secured Liabilities" means all present and future obligations and liabilities of the Chargor to the Lender, whether actual, contingent, sole, joint and/or several or otherwise including, without prejudice to the foregoing generality, all obligations to indemnify the Lender.
