

#### PAPER APART 2

This is Paper Apart 2 to the foregoing Companies Form 410 in respect of a Floating Charge dated 16th September 1999 by Glasgow Science Centre Charitable Trust in favour of The Millennium Commission

Statement as to any restrictions on power to grant further securities and any ranking provision:-

- 1. The floating charge created by the Charge shall, except as may otherwise be agreed in writing by the Chargee and subject to Section 464(2) of the Companies Act 1985, rank in priority to any fixed security within the meaning of Section 486 of the Companies Act 1985 which shall be created by the Chargor after the date of the subscription of the Charge by the Chargor and to any other floating charge and, except as may otherwise be agreed in writing by the Chargee, the Chargor is prohibited from creating subsequent to the subscription of the Charge by the Chargor, and the Chargor shall not create subsequent to the subscription of the Charge by the Charge by the Chargor any fixed security or other floating charge which will rank in priority to or pari passu with or postponed to the floating charge created by the Charge.
- 2. The Chargor hereby undertakes to the Chargee that the Chargor will not suffer to arise any set off or other third party rights in respect of all or any of the Charged Assets other than the Permitted Encumbrances provided that the Chargor and GDA shall enter into a ranking agreement with the Chargee in a form approved by the Chargee.

Agreement means the agreement dated on 7th and 24th June 1999 between the Chargee and the Chargor relating to the terms and conditions of Grant from the Chargee and/or respective terms of any sum or other liability forming part of all monies and liabilities of whatever nature actual or contingent outstanding or otherwise due, owing or incurred from the Chargor to Chargee whether dated before or after the date of the Charge.

**GDA** means Glasgow Development Agency of Atrium Court, 50 Waterloo Street, Glasgow G2 6HO.

**Insurances** means all insurances from time to time taken out in respect of the Charged Assets and all monies from time to time payable in respect of the same.

#### Permitted Encumbrances means:

- (i) a standard security dated on or around the date hereof by the Chargor in favour of the Chargee.
- (ii) a floating charge dated 16th February 1999 by the Chargor in favour of GDA.
- (iii) a standard security dated on or around the date hereof by the Chargor in favour of the GDA.

#### Interpretation in this Companies Form 410:-
