#### Financial review

The results for the year show an overall deficit of £16,386 (2006) surplus £3,836) This is mainly due to the restricted fund deficit of £15,860 arising as a result of restricted funding received last year of £11,000 being utilised this year.

It is the policy of the charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to between three and six month's expenditure. The directors consider that reserves at this level will ensure that, in the event of a significant drop in funding, they will be able to continue the charity's current activities while consideration is given to ways in which additional funds may be raised Reserves are not currently at this desired level.
