The company has not traded during the year ended 26 February 2011.

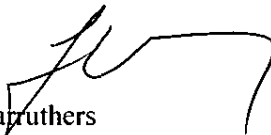

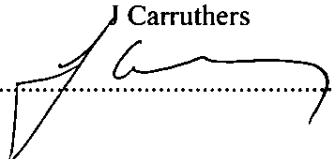
