
For the year ended 5<sup>th</sup> April 2019 the Company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

**Directors' responsibilities:**


- The members have not required the Company to obtain an audit of its accounts for the year in question in accordance with section 476,
