THIS DEED OF CONFIRMATION is granted as a deed on 19 March 2014 by:

- (1) **THE COMPANIES** listed in the Schedule (each a “**Charging Company**” and together the “**Charging Companies**”);

in favour of

- (2) **BANK OF SCOTLAND PLC** as security trustee for itself and the other Secured Parties (the “**Security Trustee**”).

WHEREAS:

- (A) The Charging Companies and the Security Trustee, among others, entered into a facilities agreement dated 19 October 2005 as amended and restated on 4 February 2008, 19 June 2009 and 29 October 2010 and amended on 20 December 2012, 1 October 2013, 20 December 2013, 30 January 2014 and 26 February 2014 (the “**Facilities Agreement**”).
- (B) Pursuant to the above, each Charging Company granted in favour of the Security Trustee the security documents to which it is a party listed in the Schedule (the “**Security Documents**”).
- (C) The Charging Companies and the Security Trustee, among others, have agreed to a further amendment and restatement of the Facilities Agreement pursuant to the terms of a restatement agreement dated on or about the date hereof between, among others, the Charging Companies and the Security Trustee (the “**Restatement Agreement**”).
- (D) Under the terms of the Restatement Agreement, the Charging Companies are required to enter into this Deed to confirm the terms of the Security Documents.

IT IS AGREED as follows:

1. **GENERAL**

Terms defined in the Facilities Agreement have the same meaning when used in this Deed.

2. **CONFIRMATION AND AMENDMENT**

Each Charging Company irrevocably and unconditionally confirms for the benefit of the Security Trustee that:

- 2.1 the Security Documents and the security granted thereunder remain in full force and effect notwithstanding the entry into this Deed and the Restatement Agreement;

- 2.2 paragraph 14 of Schedule B1 to the Insolvency Act 1986 (incorporated by Schedule 16 to the Enterprise Act 2002) shall apply to the floating charge contained in each of the debentures and bond and floating charges listed in the Schedule;
- 2.3 with effect on and from the date of this Deed, the Security Documents will be amended and supplemented by this Deed so that all references in the Finance Documents to the Security Documents shall include this Deed and this Deed shall be read as one with the Security Documents; and
- 2.4 with effect on and from the date of this Deed, any reference in any Finance Document to a Finance Document will include such Finance Document as amended, varied, supplemented, novated, restated or replaced from time to time.

3. **COUNTERPARTS**

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

4. **PARTIAL INVALIDITY**

If, at any time, any provision of this Deed is or becomes illegal, invalid or unenforceable in any respect under any law of any jurisdiction, neither the legality, validity or enforceability of the remaining provisions nor the legality, validity or enforceability of such provision under the law of any other jurisdiction will in any way be affected or impaired.

5. **GOVERNING LAW**

This Deed is governed by English law.
